#### GREETINGS:

In the name of the Commonwealth of Massachusetts, you are hereby directed to notify and warn the inhabitants of the Town, qualified to vote in the elections and Town affairs, to meet at the Town Hall in said Clinton on Monday, the fifth day of June 2023 at 7:00 P.M., then and there to act on the following articles:

## ARTICLE 1

To receive the reports of the Town officers and to act thereon.

#### **ARTICLE 2**

To see if the Town will vote to fix the salaries and compensation of all elective officials of the Town, as provided by Chapter 41, Section 108, of the Massachusetts General Laws, said salaries and compensation to be effective from July 1, 2023 to June 30, 2024, and to raise and appropriate a sum of money therefore, or act in any manner relating thereto.

#### ARTICLE 3

To see if the Town will vote to raise and appropriate from the current tax levy or transfer from available funds such sums of money as may be deemed necessary to defray town charges from July 1, 2023 to June 30, 2024, as those charges appear in the Finance Committee Report of Recommendations, or act in any manner relating thereto.

To see if the Town will vote to raise and appropriate or take from available funds the sum of \$43,630.00, or any other sum, said sum to be expended by the Police Chief to fund retroactive wages as part of a negotiated agreement between the Town of Clinton, through the Select Board, and Public Safety Dispatchers, through MassCOP Local 490, for the period July 1, 2022 to June 30, 2025, having been negotiated in accordance with M.G.L. Chapter 150E, as amended, or act in any manner relating thereto.

To see if the Town will vote to raise and appropriate or take from available funds the sum of \$60,850.00, or any other sum, said sum to be expended by the Department of Public Works to fund retroactive wages as part of a negotiated agreement between the Town of Clinton, through the Select Board, and the American Federation of State, County & Municipal Employees – Council #93 for the period July 1, 2022 to June 30, 2025, having been negotiated in accordance with M.G.L. Chapter 150E, as amended, or act in any manner relating thereto.

To see if the Town will vote to raise and appropriate or take from available funds the sum of \$58,385.00, or any other sum, said sum to be expended by the Department of Facilities & Grounds to fund retroactive wages as part of a negotiated agreement between the Town of Clinton, through the Select Board, and the American Federation of State, County & Municipal Employees – Council #93 for the period July 1, 2022 to June 30, 2025, having been negotiated in accordance with M.G.L. Chapter 150E, as amended, or act in any manner relating thereto.

# ARTICLE 36

To see if the Town will vote to initiate the process to aggregate electrical load pursuant to M.G.L. c. 164 § 134 and, further, to adopt the following resolution:

WHEREAS, the Commonwealth of Massachusetts has engaged in a process to establish a competitive market place through the restructuring of the electricity market; and

WHEREAS, citizens of Clinton have a substantial economic and social interest in terms of greater customer choice and opportunities for savings in this restructured market; and

WHEREAS, the Town of Clinton hereby finds that it may be in the interest of its citizens who are electric ratepayers, both residential and commercial/industrial, to develop and secure such approvals and enter into appropriate agreements with consultants, experts and attorneys in connection with the establishment and operation of an electricity aggregation plan.

BE IT THEREFORE RESOLVED that the Town of Clinton hereby:

Publicly declares its intent to become an aggregator of electric power on behalf of its residential and business electric customers and to reestablish such plan if its operation is suspended; and

To negotiate and enter into such contracts for power supply pursuant to the plan or services for such plan, with the understanding that if a power supply contract is executed, individual consumers would retain the option not to participate in the aggregation plan and, instead, to choose any electricity alternatives they desire and, further, to take such other action relative hereto as may be appropriate and necessary, or act in any manner relating thereto.

To see if the Town will vote to amend Article 1, Section 1 of the Administrative By-Laws of the Town of Clinton by changing the date for the Annual Election of Town Officers from the Second Monday in June to the First Monday in May, or act in any manner relating thereto.

#### **ARTICLE 38**

To create an Agricultural Commission to address and represent agricultural and forestry issues and interests in the Town of Clinton.

The mission of the Commission shall be to:

- 1.) Represent the Town's farming and forestry community internally and externally;
- 2,) Encourage, promote and support the pursuit of farming and forestry in the Town both as a business and as a community resource; and
- 3.) Promote the protection, preservation and economic use of farmland and forestland within the Town.

The duties and responsibilities of the Commission shall include, but not be limited to:

- 1.) Serving as representatives, advocates, educators, facilitators and/or mediators on farming and forestry issues both within the Town and externally;
- 2.) Advising the Select Board, Conservation Commission, Board of Assessors, Board of Health, Planning Board, Zoning Board of Appeals and other Town bodies on all matters pertaining to farming or forestry activities in Town;
- 3.) Engaging in projects and activities, including educational programs and community events, to promote the business, activities and traditions of farming and forestry, as well as farm and forest land protection in Town;
- 4.) Developing warrant articles, policies and procedures advocating and promoting agriculture and forestry; and
- 5.) Reporting to the Annual Town Report on its projects and activities.

The Commission shall consist of four members. At least two members shall be actively engaged in farming, animal law/welfare/education, landscaping/horticulture or forestry related activities. The members shall serve three-year terms each. Any vacancies shall be filled by appointment by the Select Board, based on the recommendations of the Commission, for the unexpired term of the vacancy in order to maintain the cycle of appointments.
